



## ANNUAL JEWELRY DESIGN COMPETITION 2024

Hawaii Jewelers Association is proud to celebrate another year of Hawaii's jewelry designers with our Annual Jewelry Design Competition. We encourage you to share your original jewelry creations from the past year along with your inspiration in creating these pieces with your fellow HJA members. In-person voting for the People's Choice awards in each category will be held at the Annual Banquet Saturday, October 26, 2024. Finalists and Winners will be announced at the Banquet.

## DESIGN COMPETITION RULES & INFORMATION

### Competition Categories

The three competition categories that entrants may submit pieces for are:

- |                             |   |
|-----------------------------|---|
| 1. Jewelry under \$5,000    | Any jewelry design with a retail price* under \$5,000       |
| 2. Jewelry \$5,000 and over | Any jewelry design with a retail price* of \$5,000 and over |
| 3. Hawaiian Themed          | Any jewelry design with a Hawaiian theme                    |

\* Retail price is set by the designer or the firm the designer is entering under.

### Judging

A panel of three judges will score each entry. The entries will be evaluated in the following criteria with maximum points for each noted:

<u>Criteria</u>	<u>Maximum Points</u>
1. Overall Design	40
2. Marketability	20
3. Practicality/Wearability	20
4. Craftsmanship	20

Each judge will award a maximum of 100 points for the entry. The points of all three judges will be totaled and averaged to determine the winner. There will be three places awarded for each category. In addition, an entry may receive two (2) bonus points (added after the judged scoring) if the entry qualifies as "Made In Hawaii" (designed and crafted in the State of Hawaii). Each winner will receive a framed award certificate with your company's name and be featured on our website, social media, and other industry news. The piece with the overall highest score will also be awarded **Designer of The Year**.

### Design Competition Rules

1. All jewelry must be original and designed by a HJA member in good standing at the time of the competition.
2. The entry piece must have been produced within the last 18 months.
3. Only precious metals (gold, silver, platinum, or palladium ) may be used.
4. All gem stones must be genuine. Any enhancement or treatments must be fully disclosed.
5. A designer may enter a maximum of one entry in each competition. There is no limit to the number of individual designers entering who are employed by the same HJA member/company.
6. All entrants waive any and all claims against the Hawaii Jewelers Association (HJA), its individual members, officers, or any HJA representative, associate or employee for any issue arising from the handling, condition, loss or theft of the jewelry being submitted for competition entry.
7. The entry piece(s) must be delivered by **Wednesday, October 16<sup>th</sup>, 2024 by 5:00 PM to Opal Fields** (International Market Place, Waikiki).
8. All competition entry piece(s) are to be submitted with a completed and signed competition application form indicating that the entrant has reviewed, understands, and agrees with all the competition rules.
